Athens, Greece – 5 December 2019 – MYTILINEOS' Metallurgy Business Unit has joined the Aluminium Stewardship Initiative (ASI) as a Production & Transformation member.

ASI is a global, multi-stakeholder, non-profit standards setting and certification organization, that has developed an independent certification program to ensure that the principles of Sustainability, Corporate Social Responsibility, Governance and Human Rights are increasingly integrated into the production, use and recycling of aluminum.

Major global aluminium / alumina producers, such as Rio Tinto, Alcoa Hydro and Rusal, have joined this initiative, with a commitment to maximize the contribution of aluminium to a sustainable society.

The ASI standards set out principles and criteria relating to society, the environment and governance in order to ensure compliance with the sustainability commitments of the aluminum value chain.

The ASI membership reflects MYTILINEOS' commitment to sustainable production, including the objective of achieving 100% RES sourcing for the Metallurgy Business Unit by 2030, as recently announced by the Company's Chairman and CEO, Evangelos Mytilineos, during the ceremony for the foundation of the new CCGT.

As Mr Dimitrios Stefanidis, General Manager of MYTILINEOS' Metallurgy Business Unit stated: "Sustainable Development is a top priority for MYTILINEOS and it's expressed through responsible production of bauxite, alumina and aluminium as well as an ongoing self-improvement and incessant learning process aimed at increasing our positive impact on the greater society. For us, joining the ASI represents a creative challenge and a solid commitment, fully aligned with the vision of the European Union, to move swiftly towards carbon neutral production."
